Your application must be received within 30 days of placing your license (signing DBPR form) with a Broker or the Broker will be billed for a non-member salesperson.

You must complete the ORIENTATION CLASS requirement within 3 months of making application or your status will revert to non-member salesperson. Additionally, you will not have Realtor® status and you will forfeit your application fee. **PER NAR POLICY...UNTIL YOU HAVE COMPLETED ORIENTATION YOU MAY NOT USE THE TERM “REALTOR®”** unless you are currently a Realtor® in another board.

Upon completion of ORIENTATION you may attend the next available INDUCTION. You will receive the schedule for Orientation and Induction at the time of your application appointment.

**OPTIONAL FEES**

**KEY/LOCKBOX FEES** – The optional Supra Key and Lockbox service is available only to Venice Board Members. In the event my application is approved, I agree as a condition of membership to complete the indoctrination course of the Venice Area Board of REALTORS and otherwise on my own initiative to thoroughly familiarize myself with the Code of Ethics of the National Association of REALTORS, including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the Board and the Constitution, Bylaws, and Rules and Regulations of the Board, the State Association and the National Association, and I further agree to complete satisfactorily a reasonable and nondiscriminatory written examination covering such Code, Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate, all as from time to time amended. Finally, I consent and authorize the Board, through its Membership Committee or otherwise, to invite and receive comment furnished to the Board by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

Note: Applicant acknowledges that if accepted as a Member and he/she subsequently resigns or is expelled from membership in the Board with an ethics complaint or arbitration request pending, the Board of Directors may condition renewal of membership upon applicant's verification that he/she will submit to the pending ethics or arbitration proceeding and will abide by the decision of the Hearing Panel; or if applicant resigns or is expelled from membership without having complied with an award in arbitration, the Board of Directors may condition renewal of membership upon his/her payment of the award, plus any costs that have been established previously as due and payable in relation thereto, provided that the award and such costs have not, in the interim, been otherwise satisfied.

Note: Dues payable to the Venice Area Board of REALTORS are not tax deductible as charitable contributions. Portions of such payments may be tax deductible as ordinary and necessary business expenses.

Note: No refunds will be given to members who terminate their membership or whose membership is terminated or suspended during the calendar year in which the dues are to be applied. State and National dues will transfer to a Board or Association in Florida. MLS fees will also transfer if both boards/associations are in the same MLS system.
